CONDITIONS OF SALE

Interpretation

- (a) In these Conditions, the Company means Stevly Ltd. or any subsidiary company or agent authorised by them and 'the Purchaser' means the person or persons, firm or company purchasing from or doing business with the Company.
- (b) 'The Goods' means all products supplied by the Company to the Purchaser whether by means of sale, hire rental or otherwise and whether the property of the Company or distributed by the Company as agents for another.

General

- (a) These Conditions of Sale should be read in conjunction with any Special Conditions included in the Company's quotations.
- (b) The Company reserve the right to accept or refuse any order given on the basis of its quotations and in the event of the refusal of any order no damages or expenses of any kind shall be payable by the Company.
- (c) Any complaint about the Goods supplied shall only be entertained by the Company if made within three days of delivery and confirmed in writing.
- (d) The decision of the Company about any alleged defect shall be final and conclusive.
- (e) Credit will only be issued on returns if Delivery Note number is quoted.
- (f) Quotations and offers are given and contracts of sale are only accepted subject to these conditions. Any variation thereof by the Purchaser will be treated as inapplicable and of no effect, unless specifically agreed in writing by the Company.

Prices

- (a) The Goods shall remain the property of the Company until paid for by the Purchaser and any cheques cleared but shall be at the risk of the Purchaser as from the date of delivery.
- (b) If payment is delayed beyond the agreed terms, the Company reserves the right to charge interest on the outstanding balance at a rate of 2.5% above the base rate of Barclays Bank Limited.

Delivery

(a) The Company shall not be responsible for delay in delivery owing to matters outside the Company's control.

Indemnity

- (a) The Company shall not be responsible for any consequential loss of any description incurred by the Purchaser as a result of any failure or fault in the Goods or for any damages or personal injuries or other losses, howsoever caused directly or indirectly by the Goods.
- (b) The Company shall pass onto the Purchaser the benefit of any Guarantees or Warranties provided by the manufacturers of the Goods and any rights vested in the Company under such Guarantees or Warranties are hereby assigned to the Purchases but without prejudice to the previous sub-clause.
